CVEA is Committed to Community

Publicly owned utilities were formed to bring affordable electricity to those who needed it. At the heart of their mission was neighbors coming together to better their communities. That same spirit continues at CVEA today. As a local business, staffed by your friends and neighbors, we look for ways to make a difference - big and small.

Community Support Programs

Each year your Cooperative supports a wide variety of community groups and events. Although 2020 was quite different and many community events and activities did not take place due to the Covid-19 pandemic, CVEA still found a way to provide support and service to our community when and where it was needed most.

CVEA developed the COVID Co-op Cares Community Support Program to provide direct benefit and support to CVEA members most impacted during this difficult time.

Through the program, the Cooperative sent out \$100 grocery gift cards to individuals immediately faced with negative financial impacts related to Covid-19. Meals were provided to over 200 essential workers thanking them for continuing to work hard and keep CVEA communities going strong. Struggling local restaurants were supported when multiple meals were purchased weekly, for two months, for essential workers.

The Co-op issued a \$25 Community Cares Gift Certificate, which could be spent at most local businesses throughout the summer, to every CVEA residential member. Over \$27,000 in gift certificates were redeemed, providing a small amount of financial support for members and businesses.

Additionally, the Co-op donated roughly \$21,000 to provide additional support to local nonprofit organizations in Valdez and the Copper Basin. According to CEO Travis Million, "our Board and employees really wanted to get support directly into the hands of those who needed it most. We believed that the best way to accomplish that goal was to provide additional assistance to organizations who were already in place providing the help that people needed." CVEA was able to provide additional financial assistance to the Valdez Senior Center to support an additional food delivery day or Meals on Wheels, the Valdez Pharmacy to support those having difficulty paying for much needed medicines, the Copper Basin Seniors to support local seniors needing a little extra assistance, Connecting Ties Supportive Employment Program, Advocates for Victim's of Violence to support their grocery and gas gift card support program, the Valdez Co-op Preschool scholarship support program, Stepping Stones Learning Center to support struggling families and provide water bottles and masks for all of the children, and to the Copper Basin Pregnancy Center, Copper River Basin Child Advocacy Center, and CRNA Food Bank to provide general support for increased need.

Finally, CVEA held a summer activity program with financial rewards and prizes for kids age 2-18 to support their physical, social, and mental well-being. Roughly 200 kids participated throughout the summer. So much fun was had, and close to \$6,000 in prizes were given away.

In all, CVEA provided hundreds of hours and over \$70,000 to come to the aid of our communities and demonstrate to our members that we are all in this fight together.

In addition to the Covid support program, the Co-op was able to provide gifts, door prizes, donations, and auction items to reduced capacity or virtual variations of some very important meetings and events throughout the year. Organizations included the Valdez Museum, Copper Valley Chamber of Commerce, Relay for Life, Valdez Adventure Alliance, the Valdez and Copper Basin Seniors, and the Valdez Consortium Book Basket auction, to name a few.

CVEA typically supports many educational and youth programs including participation in career and health fairs, classroom presentations, and tours to students and youth groups. Most of these events were cancelled this year, but the Cooperative stands at the ready to safely participate in these events in 2021. Additionally, employees have stepped up their participation on many community work groups, task forces, and committees; providing much needed community support and leadership.



Community Foundation

The CVEA Community Foundation (Foundation) was created to help the Cooperative do more for the communities it serves. The Foundation provides scholarships for students and contributions to educational, scientific, and charitable organizations in our communities. The Foundation is funded by capital credits that have escheated back to CVEA, generous donations from CVEA members and vendors, and fundraisers.

Annually, the Foundation awards thousands of dollars in educational scholarships as well as scholarships for students to participate in industry youth leadership programs like the Idaho Youth Rally.

Each year the Foundation contributes funding to local nonprofit organizations looking to fund new or expanding programs that meet the Foundation's contribution guidelines.

In 2020 the Foundation Board of Directors awarded \$17,575, funding 100 percent of the amount requested by 12 local nonprofit organizations serving CVEA communities. Congratulations to Wrangell Institute for Science and Environment, Copper River Watershed Project, Copper Valley Community Library, Copper River Basin Child Advocacy Center, Copper River Hockey Club, Valdez Co-op Preschool, Valdez Adventure Alliance, Valdez Museum, Valdez 6th Grade Science, Valdez 6-8th Grade Skills, Stepping Stones Learning Center, and Valdez Torpedos Swim Club.

The Foundation Contribution Season begins in July, applications are due in August, contributions are announced in November, and checks are typically distributed in December. Local organizations whose missions support educational, scientific, or charitable purposes are encouraged to apply.

The Foundation's Board just approved \$19,254 to fund the 2021 contribution season, which will be the largest amount of available funds to date.

Congrats, APA Award Recipients

Electric consumers may not think about what goes on before, during and after they flip the switch in their home and businesses, and that's just the way Alaska's electric utility employees want it to be.

But once a year, the Alaska Power Association—the statewide trade association for electric utilities—honors a few outstanding Alaskans for their contributions to the industry and, by extension, every Alaskan electric consumer.

This year, APA honored four individuals inside and outside the electric utility industry for their contributions to making it all work. Recipients were recognized during the Alaska Power Association and ARECA Insurance Exchange Virtual Annual Meeting on November 4.

The David P. Hutchens Public Service Award was created as a memorial to Dave Hutchens, who served as APA's executive director from 1979 to 1996. Award recipients are individuals outside the utility industry who have provided exceptional service in the interest of electric consumers in Alaska.

This year's Hutchens Award recipient, Jeff Williams, Power Cost Equalization program manager at Alaska Energy Authority, helms a program vitally important to thousands of Alaskans.

Jeff has benefitted Alaskan electric consumers through his steady guidance and program advice. Service, helpfulness and advocacy sum up Jeff's character. He's helped hundreds of rural communities through the equalization program.

The Alaska Power Association Hatcher-Williams-Turkington Employee Award recognizes electric utility industry employees and commitments to the industry and their communities. This year's award recipient is Julie Estey, senior director of external affairs and strategic initiatives at Matanuska Electric Association. Julie is a key part of her co-op's executive team and was nominated based on her professional attributes that serve both the utility and the community.

Julie was honored for her ability to bring diverse groups together to solve issues, which greatly benefits her co-op and every consumer who receives power. Julie also maintains a level of excellence in communicating Railbelt views on legislative and regulatory matters, calling on her ability to build relationships and clearly communicate in an arena that requires sharp tactics and forethought on what comes next.

The APA President's Award is not bestowed every year. It waits for a special moment and a special person. Winners of the award don't typically fit into any of the usual award categories.

This year's APA President's Award recipient is Sen. John Coghill, R-North Pole. He has been consistently interested and involved in issues ranging from PCE to Railbelt legislation. His deep knowledge of the legislative process and the electric utility industry has benefited APA and its members in numerous instances throughout the years. Sen. Coghill received the APA

The highest honor APA gives its own in the industry is the Mason LaZelle Achievement Award. This award recognizes extraordinary contributions to the electrification effort in Alaska.

CVEA Bylaws Amendments

In 2020, CVEA leadership completed a detailed review of the corporate Bylaws to ensure they are consistent with updated industry standards, and accurately represent the way the Cooperative conducts business.

Recommended changes were presented to the Board of Directors at the Regular Board Meeting in June and a public meeting was held in August. Final staff recommendations will be presented to the Board in December and member recommendations will be provided for approval in January.

CVEA members may propose Bylaws amendments for placement on the 2021 ballot by filing a petition with the Board of Directors. The petition must be signed by at least 10 percent of the membership and filed at least 90 days before the annual meeting. Please submit any amendments by petition prior to 6 p.m., Thursday, January 7, 2021. Petitions may be emailed to sscheidt@cvea.org or submitted to the Glennallen or Valdez office. Please contact your local office to schedule an appointment to drop off submissions.

In an effort to receive additional member input on proposed Bylaws changes, a second public meeting has been scheduled for Wednesday, January 20, 2021, at 5:30 p.m. At the meeting, recommended changes will be provided, questions answered, and public comments accepted. Members will have an opportunity to attend virtually via Zoom, and registration will be required. To register, please contact Nancy Heidelberg at 822-8342 or email nheidelberg@cvea.org. Specific details will be provided at that time.

The Board will approve amendments for the ballot at their regular meeting on January 21, 2021. Amendments voted on by the Membership will go into affect after the election results are provided at the 2021 Annual Meeting on May 4, in Valdez, and May 6, in the Copper Basin.
