Three director seats will be up for election in 2008; two seats are held by Jeff Saxe in Valdez and James Manning in the Copper Basin. These seats will be filled for three year terms. In addition, the seat recently vacated by Laura Meadors will be up for election for the remaining two years of her three year term. Joe Freitag has been appointed to fill this seat until the election.

As a director, you can help make

decisions that impact your neighbors and friends, the folks up and down the T-line, and all cooperative members.

The Board meets once a month, normally on the third Thursday. Members also travel to participate in statewide and national meetings. Directors serve three-year terms.

If you have been a member of CVEA for at least 12 continuous months, are a member in good standing, and are not an employee or close relative of an incumbent director or employee, you may be eligible to be a director. In order for a member to become a candidate, they must participate in a petition process. Candidates must complete a petition signed by at least 15 active CVEA members and submit the petition to the CVEA office in their district by 5:00 p.m., Friday, February 15, 2008.

\$9,500 in CVEA Scholarships Available in 2008

This year, \$9,500 is available for CVEA scholarship programs. These scholarship programs are funded with unclaimed capital credits that have escheated back to the Cooperative.

For high school seniors, the Board has authorized offering four \$500 general scholarships. Half of the scholarships will be awarded in each district. The scholarships are awarded for vocational, technical, apprenticeship training or a college degree program.

Students interested in the electrical industry are eligible for a \$1,000 scholarship. High school seniors who intend to pursue a field of study that contributes to the development and improvement of the electrical industry have the opportunity to be awarded this scholarship. One will be awarded in each district.

Help Wanted for Credentials and Election Committee

A very important part of the annual meeting election process is the Credentials and Election Committee.

The people who serve are responsible for validating the signatures on the backside of the envelopes and then counting the ballots.

The committees, one for each district, are comprised of interested members who are not employees, directors, candidates or close relatives of these persons.

The Board will appoint committee members for each district in February. Service on the Credentials and Election Committee takes place during the m onth prior to the annual meeting, with most of the work performed the week prior to the meeting.

CVEA is excited to announce two new scholarship opportunities for the upcoming year. In 2008, CVEA will award two Community College Scholarships, one in each district, to a member planning to attend Prince William Sound Community College for the 2008-2009 school year. These new \$1,500 community college scholarships are designed to assist students with the costs to attend PWSCC.

In addition, the Board has authorized two Idaho Youth Rally scholarships. The Idaho Youth Rally scholarship provides an opportunity for sophomores and juniors attending high schools in our service area and allows students to practice leadership, teamwork, and communication skills while learning about electric utility issues.

Scholarship recipients will be decided in April and announced at CVEA's Annual Meeting and at 2008 graduation ceremonies.

The Scholarship Selection Committee Needs You
