

2009 CVEA Board of Director Elections Meet the Candidates

The CVEA Board of Director elections are fast approaching. Ballots will be mailed by March 23 along with candidate biographies and your official annual meeting notice.

To be counted return ballots must be received in the designated post office box by 5 p.m., Tuesday, April 7, 2009.

There is one seat up for election in the Copper Basin district and two seats in the Valdez district.

Six candidates have been nominated to fill these seats via the petition process. There are two candidates in the Copper Basin and four in Valdez.

You, as a CVEA member, will soon have the opportunity to exercise your right to vote for the candidates of your choice.

Question 1

I've spent 35 years in the construction industry building roads, pipelines, homes and power lines. I have a good idea what works and doesn't in construction. This will serve well in feasability studies for future projects and managing current projects.

Question 1

I have worked for many years as an engineer, scientist, and manager at the Los Alamos National Laboratory and likewise at an instrumentation business using technology developed at the National Laboratory. This experience coupled with the perspective gained on the staff of the Regional Citizens' Advisory Council in Valdez is directly relevant to the duties and responsibilities of a Director at CVEA.

Question 2

CVEA is already one of the finest and best professional organizations with which I have been associated. It is important that this good work continue and that all employees continue to receive training appropriate to their professional development.

Question 3

CVEA's acquisition of Solomon Gulch and its development of Allison Lake positions the coop for the future. Longer term, there is considerably more hydro power potential to be developed plus possibly renewable wind and geothermal resources. Gas needs to be integrated into the CVEA power supply once available and the coop should integrate into the Railbelt grid, in a fiscally responsible fashion, as the State of Alaska develops its transmission infrastructure.

Question 1

During my 57-year residency in Alaska, the last 28 of which have been in Valdez, I have held positions of supervisor, area-wide manager, and state sales manager for major companies. Over this time frame, I have also served on many boards and commissions. From them I learned what the duties of a board consist of.

Question 2

1. To keep working on ways to produce electricity other than using fossil fuels, i.e. hydro, wind, geothermal, and methane gas.

2. To bear in mind that all forms of producing electricity are expensive.

Question 3

1. Get an intertie between the Railbelt through Sutton to Glennallen, then Glennallen to Delta, with funding from the state of Alaska.

2. An intertie could even allow CVEA to sell electricity if the occasion arose.

3. Encourage the local refinery to get back on stream ASAP. The loss of the refinery impacts CVEA's bottom line.
