# 2024 Director Election

# Meet the Candidates

The CVEA Board of Director election is fast approaching. Ballots will be mailed by March 30, along with candidate biographies, and your official annual meeting notice.

To be counted, return ballot envelopes must have a valid signature and be received in the designated post office box by 5 p.m., Tuesday, April 23, 2024.

Candidates have been nominated via the petition process. You, as a CVEA member, will soon have the opportunity to exercise your right to vote. Please exercise this right.

Per CVEA Bylaws, a minimum of 10 percent of the district membership must return their ballots to constitute a valid election. For this reason, even though there may be only one candidate for the open seats, the co-op still needs you to vote.

All valid ballots, with signed ballot envelopes, returned by the deadline will be entered to win a \$50 CVEA energy credit. To learn about the candidates, they were asked to respond to three important questions. The questions are listed here and the candidate responses follow.

#### **Question 1**

#### **Question 2**

CVEA continues to explore renewable resources as well as new and emerging technologies, to help improve efficiencies in the system. (whether transmission, distribution, or generation). Preventative maintenance, right-of-way clearing, and maintaining a trained workforce are key items as well. CVEA also continues to work with other utilities to formulate the Alaska Railbelt plan. This is a long-term plan and will require federal funding, but if it does happen, it will benefit the entire railbelt system. I will do everything I can to support this mission.

#### **Question 3**

One major task of any cooperative is to constantly strive to lower the cost of electricity for its members. Solomon Gulch and Allison Creek are helping to offset the need for diesel generation now and for decades to come, thereby reducing the need for fossil fuels.

Additionally, the VMT Intertie has great potential to further reduce the use of fossil fuel. This Intertie is scheduled to come online first quarter 2024.

Other projects contributing to lower rates are the Advanced Metering Infrastructure (AMI), and soon the OMS (Outage Management System), both will be saving time, man hours, and equipment.
