

Understanding Your CVEA Electric Bill

1 - Customer Charge



Monthly charge that covers a portion of the cost to produce the monthly bill:

The cost of meter reading expenses, billing, and collection activities.



Residential: \$20



Small Commercial: \$30

Large Commercial: \$100

2 - Energy Charge



Billed per kilowatt-hour (kWh) delivered:

This charge is also known as the distribution charge and is the cost to deliver power to you, including system operation and maintenance, customer service, member services, administration, depreciation, taxes, and interest.

3 - G&T Charge



Covers the cost of generation & transmission of power:

This charge is the cost per kWh to generate power at the CVEA power plants and transmit the power into the distribution system that brings power to your home or business.

4 - Fuel Charge



Actual cost of fuel used to generate power in CVEA plants:

The Fuel Charge changes as the cost of fuel fluctuates. CVEA's vision is to reduce our dependence on fossil fuel, which will reduce this cost.

5 - Heat Credit



A credit back to members per-kWh:

When the Cogen Plant is producing heat revenue, members see a credit per kWh on their bill. This credit will only be available in the months CVEA receives heat revenue, which is typically October through May.

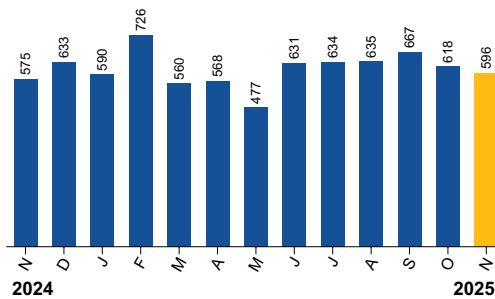
